



## 2026 Very Clever Wellness incentive (VCWi) program for Physicians

[January 2026]

Thank you for your partnership and for being a part of the Clever Care family!

We are grateful to you for making the VCVi program a success, hence would like to share the 2026 Very Clever Wellness incentive (VCVi) program for Physicians. The program is intended to improve access to preventive and chronic care for members, close clinical and pharmacy care gaps, and capture and address social determinants of health (SDOH).

**Selected IPA Physicians** are eligible to participate in the 2026 VCVi program and can receive an incentive of **\$250** for an eligible completed Annual Wellness Visit (AWV), subject to Health Plan Product eligibility.

*For new members, please prioritize scheduling their first visit within 90 days to ensure a positive experience and improve member satisfaction.*

\*Members must be enrolled with Clever Care on the AWV visit date & must be with VCVi program eligible IPA. Clever will pay only one AWV per member every year. See page 3 for the list of VCVi program eligible IPAs.

**Incentive Eligibility criteria:** AWV must be completed by the PCP. Members must be enrolled in one of the applicable Health Plan Products: Total+, Breathe+, or Longevity. The PCP must sign the **PCP ANNUAL WELLNESS VISITS (AWV) LOA/MOU** to receive incentive payments.

**Incentive qualification:** **Step 1)** Schedule the member and complete the AWV form. PCP can use the Clever Care Annual Wellness Assessment form, IPA-provided form, OR EMR visit document, which is pre-approved by Clever Care. **Step 2)** Submit completed AWV/visit documents.

## 2026 Very Clever Wellness incentive (VCWi) program for Physicians

### AWV Components

The Very Clever Wellness incentive (VCWi) program aims to complete a comprehensive face-to-face patient visit that fully documents the health status of our participating Medicare Advantage patients. The visit will reflect the patient's complete health status and disease burden and requires accurate documentation and coding to ensure the needs of each patient are met with an appropriate plan of care.

Components of Annual Wellness Visit (AWV) include the following:

- Detailed History of Present Illness (HPI), Review of Systems (ROS), Past Family or Social History (PFSH), other medical care.
- Comprehensive physical exam with vitals.
- Depression screening (PHQ-9).
- Assessment for cognitive impairment.
- Assessment of drug and/or alcohol dependence.
- **Fall risk assessment and physical & mental well-being assessment.**
- Functional status assessment with Activities of Daily Living (ADL) and iADLs, pain assessment, and Advance Directive.
- Assessment of all existing chronic and acute conditions with a proper evaluative statement and plan.
- Preventative Screenings – completion dates and/or screening schedule.
- Social Determinants of Health (SDOH) Screening (**often missed element**)

### **(Chronic Condition) Recapture and Star measures**

- Note: AWVs are expected to close all gaps related to chronic conditions recapture and Star measures.
